We, 114 civil society organizations from Brazil and around the world write to you in times of geopolitical rupture and rising climate impacts, when much of the credibility of a global transition away from fossil fuels now depends on whether the roadmap to transition away from fossil fuels becomes a real and inclusive political process – or another document that gathers dust.

We express our appreciation for the much-needed presidency-led initiative to develop roadmaps to end deforestation and to transition away from fossil fuels. **At the same time, we urge you to design and facilitate an inclusive process that ensures meaningful participation by civil society organizations and frontline communities, as well as country governments – firmly guided by science, climate justice principles and the goals of the Paris Agreement.**

In today's volatile geopolitical context, a managed, just, and orderly decline of fossil fuel production and consumption is not only a climate imperative, it is a matter of economic resilience and political stability. Continued dependence on fossil fuels exposes countries to price shocks, conflict, and coercion.

In contrast to the Baku-to-Belém Roadmap, a fossil fuel transition roadmap must be more than a pdf, it must be a different process and not become a shelf document. The fossil fuel roadmap must constitute a real, transparent, and participatory process, one that reflects the lived realities of those most affected and helps translate global commitments into credible action and accelerated implementation.

We therefore request that the roadmap process should be inclusive, transparent, and co-created. This includes active and broad participation by civil society, Indigenous Peoples and Local Communities and people of African descent, and co-leadership by Brazil together with partner countries, in particular Pacific and Latin American nations. The Pre-COP and the fossil fuel conference in Santa Marta in April offer a key platform to jointly shape the process and prepare the announced report-back to COP31.

We further urge that the design and facilitation of the roadmap process be firmly anchored in the following principles:

- **Science-led and independent**, with strong safeguards against vested fossil fuel interests, including the exclusion or strict limitation of inputs linked to fossil fuel production;

- **Comprehensive in scope**, addressing both production and consumption, licensing and subsidies, with particular attention to how developed countries meet their fair shares and obligations including the provision of finance, and to the impacts on workers and communities as part of a just transition;
- **Politically owned at the highest level**, with sustained engagement and leadership at ministerial level throughout the year, across domestic and international roadmap processes;
- **Equitable**, ensuring that the costs, benefits, and opportunities of the transition are fairly distributed across countries and communities, in line with the principle of common but differentiated responsibilities and respective capabilities (CBDR-RC);
- **Inclusive and transparent**, ensuring meaningful and decisive participation of broad civil society, people of African descent and IPLCs.
- **The roadmap should assess policy and regulatory options to ensure fossil-fuel incumbents' strategies as well as those of fossil fuel importers are aligned with 1.5°C pathways**, covering corporate governance, licensing conditions, and (where relevant) public-interest ownership or stewardship models, with clear democratic accountability and human-rights safeguards.

The success of this roadmap will be measured not by the document it produces, but by whether it breaks with fossil fuel capture and delivers a just, science-based transition in the real economy.
